Notes:

- All coaching includes a secure online client-only accountability/progress update with approx. 30 minutes worth of “virtual coaching” each month.
- The Traditional Coaching Package involves a three-month minimum commitment. After the initial three months is completed, we proceed on a month-to-month basis. *You also have the option to move into “Maintenance” mode upon completion of the initial three-month agreement. Only clients who start with the Traditional Package can switch to Maintenance.
- Sessions are conducted on Skype, phone or in person in the downtown Tacoma, WA office.
- Amounts are listed in USD.
- The number of minutes per month is based on a **calendar month**. Hours do not carry over from month-to-month.
- You will receive a Pay Pal invoice between the 20th and 25th of the month for the following month. **Payment is due by the first of the month.** Fees not paid by the first could result in a reevaluation of the coaching partnership.
- If you wish to pay by check, your check must be received by the first of each month. Details are outlined in the Coaching Agreement.
- Consistency, commitment and communication are essential to an effective coaching partnership. Consider that if you enter into this partnership, you are 100% committed to your personal and professional growth, as well as to honoring your agreements with your coach and yourself.
